

Location of proposed building within site
Location of site relative to surroundings
Orientation relative to astronomic north
Topographic relief

# 5. Geographical Coordinates

### Latitude

- Measured positive north of equator
- North America is positive
- Longitude
  - Measured positive east of Greenwich
  - North America is negative

# BRE Guidelines (U.K.) Emphasis on both daylight and sunlight

- Daylight loss of sky view
  - Established factors for LR/DR/BR
- Sunlight loss of direct sun
  - Established factors for windows
  - Established factors for gardens and OLA's

- Boston Redevelopment Authority
  - Emphasis on sunlight and daylight
  - Public open spaces and pedestrian areas
    - Transit stops, walkways, parks, plazas
    - and other open space areas

- No-build, build, and as-of-right
- ♦ 9, 12 and 3 on equinoxes & solstices
  - plus 6 pm in summer and fall

- Oakland Design Review Manual
   Actively used outdoor area
  - Gathering space with a seating area, a sunning area, a pool/fountain, planters, or other similar amenities

Actively used indoor area

 Entertainment areas, such as living rooms, dining rooms, kitchens, family rooms, etc.

Excludes bedrooms and bathrooms

Oakland (cont'd)
 Impact if shadow > 50% on
 Exterior wall of actively used indoor area
 Actively used outdoor area
 On spring/fall equinox during 2 of 3
 9 am, 12 noon, and 3 pm

Central Sydney, Australia
 Emphasis on publicly accessible spaces
 Publicly owned
 Privately owned
 12 noon to 2 pm, 14 April to 21 June

### New York City CEQR Manual

Shadow criteria applies to:

- Publicly accessible open space
- Historic landscape or resource
- Important natural features, landscaping
- Mar (Sep) 21, Jun 21, May (Aug) 6, Dec 21
- Excludes streets, sidewalks, buildings
- Excludes within 1.5 hrs of sunrise/sunset
